Key benchmark indices rallied in the week ended Friday, 16 May 2014, on expectations the Bharatiya Janata Party (BJP) led National Democratic Alliance (NDA) will be able to form the next government at the centre and that Narendra Modi will become the next Prime Minister of India. Leads and results of Lok Sabha elections on Friday, 16 May 2014, cemented those expectations as they showed that the NDA was all set to form the next government at the Centre. The barometer index, the S&P BSE Sensex, settled at a record closing high after scaling a record high above the psychological 25,000 mark in intraday trade on Friday, 16 May 2014. The 50-unit CNX Nifty also finished at a lifetime closing high after scaling a record high above 7,500 level in intraday trade on Friday, 16 May 2014. For the next week Nifty likely to trade in the range between 7450 - 7600 in the upper side and 7050 - 6900 in the lower side.
