- On the global front, Bank of Japan and Bank of Canada holds meeting on 25 April 2019 to announce key policy interest rate
- HDFC Bank will announce January-March 2019 quarterly earnings on 20 April 2019.
 ACC will declare January-March 2019 quarterly earnings on 23 April 2019. Bharti Infratel and UltraTech Cement will unveil January-March 2019 quarterly earnings on 24 April 2019. Maruti Suzuki India will announce its January-March 2019 quarterly earnings on 25 April 2019. Axis Bank, Hero MotoCorp and Yes Bank will declare their January-March 2019 quarterly earnings on 26 April 2019.

The BSE Mid-Cap index fell 43.88 points or 0.28% to settle at 15,382.57. The BSE Small-Cap index fell 0.98 points or 0.01% to settle at 15,021.20.

Domestic shares advanced on first trading day of the week on Monday, 15 April 2019 in line with most Asian stocks. The barometer index, the S&P BSE Sensex, rose 138.73 points or 0.36% to 38,905.84. The Nifty 50 index rose 46.90 points or 0.40% to 11,690.35.
